Submission of false or misleading claims/ proofs, undue claims against Debit Notes raised by IKIWL / Rejection of materials due to Quantity or Quality deviations / LD etc., wherein IKIWL has already rejected prior claims on said bills shall not be entertained and shall be subjected to legal proceedings.
